Langlade County Highway Department utilizes: Salt, Salt Brine, and Salt/Sand mixture (approx. 5% salt)

Trucks are set up differently to apply each product.

Single axle plow trucks have tailgate spreaders have either salt plates or salt/sand plates installed in them, they can be changed. Some of the spreaders have 150 gallon brine tanks installed that pre-wet the salt or salt sand with brine as it is being applied.

Quad axle plow trucks have wedge shaped 2,000 gallon brine tanks that we put salt on top of so these trucks have salt and salt brine capability. They are typically used on high volume roads with good places to turn around on the State and County Highway systems.

We have applied, with towns approval, all of the available products at one time or another.
