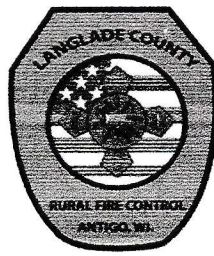

I am pleased to provide you with the following report on the personnel, and calls for service in ~~2024~~ *2025*

This year was a little more active as far as calls go, we were up to 60 calls from last years 49 calls.

Our training hours this year we also up with 90.5 hours this year and 75.5 last year, with an average of 10.76 participants per training.

Training

Our training schedule is nights a month held on the first and third Mondays with our monthly meeting held on the second Monday. We train with other departments as much as possible so we can all be efficient on the fire ground.

We held 38 training sessions for 90:30 class hours and a total of

919:30 man hours up from 731 last year.

Our trainings throughout the year were: Pump operations, search and rescue and fire attack with TOA. Some trainings this year were with our new air packs, putting them into service and on how to use them. We did our annual pump and drafting training where we draft water from bridges in the townships while washing the salt and sand from the bridge decks. We held an EVOC (Emergency Vehicle Operating Course) at our station. We trained with Birnamwood Fire on rope rescue. We continue to train on our 1 minute drill where we practice pulling hose from the truck, charging the hose and hitting a specific target (fire) with water simulating putting water on a fire. We aim for doing this in under a minute. We've done ladder training here at the station, and we have done pre plan tours of area farms or business'

Public Relations

We have done fire safety public education with local 4H clubs, and numerous events with our cheese curd wagon for fundraising.



This year we received a \$300.00 donation from the Eager Beaver 4H club.

RFC has also received \$4,000.00 from CARR foundation

Our annual Remington fund money this year was \$4,500.00

Langlade Co. Fair Board donated \$250.00

Tony's Hotrod Shop donated \$200.00

Larry Noskowiak Family donated \$2000.00

And an Anonymous donation for our air pack upgrade of \$15,000.00

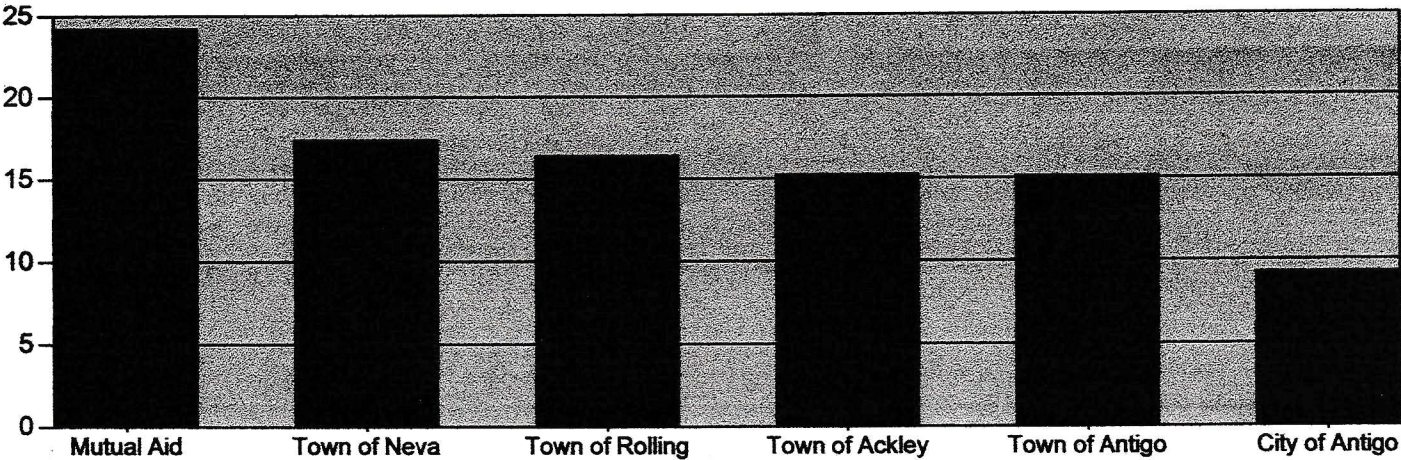

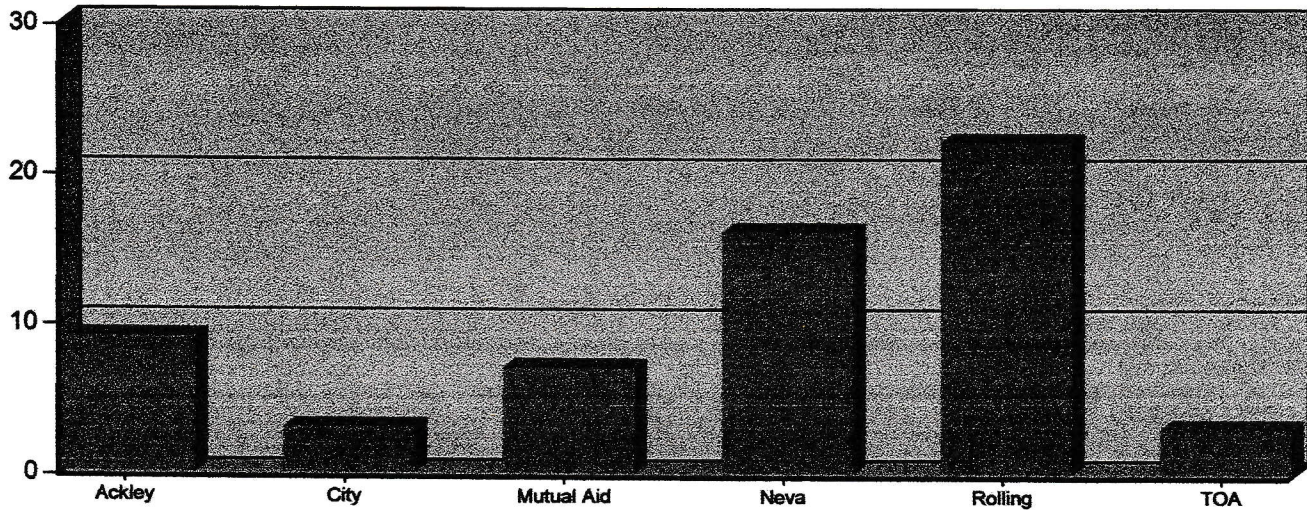

Mike,

Attached is an updated proposal for the 3000 gallon stainless tank. I have listed the swivel dump as an option. I did a quick run through attempting to compare the CFB proposal to my stainless proposal. It was hard because they do not have a lot of detail listed in their proposal leaving me to guess at a number of items. Typically in the past our pricing has been very close with CFB when we compare a poly tank build to a poly tank build with our stainless tank normally coming in less than the poly builds leading me to believe the configuration proposed from CFB has a very basic package included. A few examples, they state it will have a battery maintainer but not the model, what does they portable pool have for a cover, the standard vinyl cover or diamond plate aluminum like ours?

I was able to pick up a few items that should be discussed and used to make your selection and depending on where the group puts value will determine who they want to build their truck.

- CFB has a 10 yr warranty on their body we have a 30 yr warranty on our stainless steel body and framework.
- CFB tank has a lifetime warranty our stainless tank has a 30 yr warranty
 - Questions to ask
 - who pays for repainting if there is an issue
 - Who pays for removal of accessories to access the tank if needed
 - Will the repair company come to the builders shop or does the tank need to be removed for service and transported to the tank builders shop? Who pays for removal and transportation? Is the answer for the full 30 years or does it change after a specified time?
 - Our warranty is not prorated and we cover all expense. Department has to bring the truck to us after first year, we cover the rest.
- Swivel dump verses 3-way, both electronic
- Warning light package is not DVI
- Light bar configuration
- Fewer step lights
- Fewer ground lights
- 3 different brands of warning and DOT lights
- Port a Tank cover, vinyl or aluminum
- Pump configuration – department provided pump
 - We have electric valves located tight to the tank to prevent freezing
 - All valves are Elkhart valves

My best estimate is these noted differences are around \$15,000 to \$20,000 of cost. It is hard to specify an exact dollar amount due to the lack of detail in the proposal. I suspect that there are other differences between the our proposals that I am not able to identify due to the lack of details.

Rural Fire Control New Tender Project

Our current tender (tanker) is a 1999 International 4900 chassis, purchased from Quinlan's Equipment in Antigo, with a 3500 gallon refurbished stainless steel tank/body package from Stainless & Repair based in Marshfield. The truck has served us well, is in very good condition and if we update, it should bring us premium on the used market.

The National Fire Protection Association (NFPA) recommends that any apparatus over 25 years old be retired from service entirely. Even if the vehicle is well-maintained, the difficulty of sourcing replacement parts and the gap in safety technology make it a liability for emergency operations. NOTE: this is NOT a requirement but a recommendation for fire departments to follow.

The EPA will be implementing "Phase 3" emission standards for 2027 model year on-road vehicles. The additional technology and components to make vehicles comply is estimated to increase truck costs \$25,000 or more over a 2026 model order.

NEW TRUCK CHASSIS

Quinlan's Equipment has quoted us a new HV607 International truck 380 horsepower L9 Cummins engine with a 6 speed Allison transmission equipped to handle a 3500 gallon tank apparatus for \$122,095. By the time we approve purchase the price may go as high as \$125,000. Quinlan's will order the truck with a \$5000.00 downpayment with the balance due when delivered to the body company.

NEW TANK/APPARATUS

Our committee has looked at a few options.

1. S & R Truck LLC, Marshfield, WI (new company that took over Stainless & Repair) quoted us a 3500 gallon single shell Stainless Steel tank and **Pump ready compartment**. Full lighting package and 3 way rear electric actuated dump. They offer 3 payment options:

UP FRONT PAY: 13% discount if paid up front **\$247,393.00** within 60 days of order

PROGRESSIVE PAY: 7% discount **\$264,198.00**, 20% in 60 days of order, 30% -13 months from signing and final balance upon delivery.

DELAY PAY: No discount **\$283,804.00**, 10% in 60 days of order balance at time of delivery.

LOWEST PACKAGE PRICE \$372,393.00

2. Custom Fab & Body LLC, Marion WI quoted us a 3000 gallon poly tank, full light package, **1 Newton swivel dump with telescopic extension**. Can bring capacity up to 3500 gallon with a small price increase. **\$196,650.00** half down payment up front, balance at delivery

PACKAGE PRICE: \$321,650.00

The S&R package is \$50,743.00 more if we use their pay up front discount, more on the delay pay.
Things to consider: S&R has a longer warranty on the body, paint and plumbing. S&R is quoting 3 dump valves vs. a single swivel dump valve. S&R is an all stainless steel body and cabinets, Custom fab is mostly aluminum. But the biggest difference to me is that the S&R package is nearly 2 feet shorter. Our truck bay is about 32.5 feet door to wall. This would only give us 9" clearance with the Custom Fab truck.

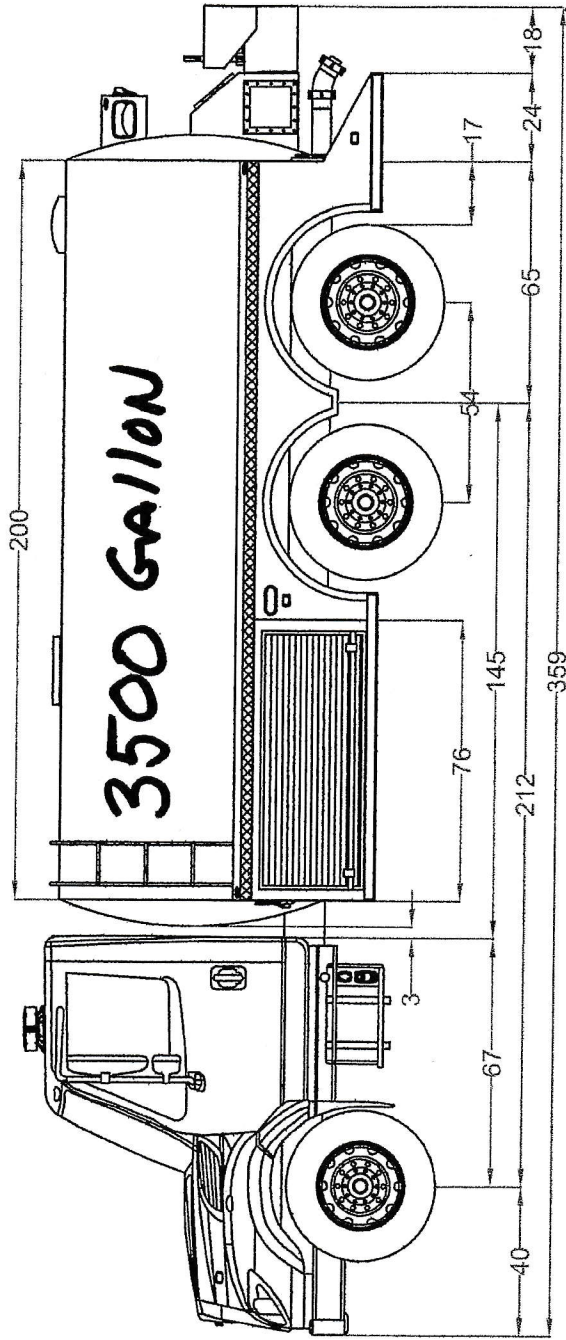
