- G. Neva Broadband/Angie Close:** Langlade broadband commission has a proposal about getting fiber laid to the Neva Lake area. There is a new grant announced for November. Cirrinity has a map showing where the fiber would be laid. It is a proposed project of 15 miles of fiber to homes and businesses. The estimated cost is 1.2M it would be covered by grants and matching funds from multiple sources. They are looking for as much funding as we can find in the budget. They would not charge for the town hall internet or phone. 25-35,000 average fund match. Discussion held.
- H. Road Inspection: Byers Rd Pulverize/Northeast fix road sides:** Doug said they did a third road inspection. We asked the county if they are going to be pulverizing byers to the line. They asked Northeast about the work they did if they could come back and fix the shoulders.

Otto did a good job with the sign for the cemetery.
