- G. Resolution on Idle Site Grant Program: AC Wildman Holdings WI LLC: Angie Close is the executive Director. She talks about the resolution that was passed for a site and wants support for the new one. The town must be the applicant for the new resolution and there are no financial responsibilities on the town from this it is. Discussion is held. Michael Krahling says they need to find property to branch out projects on. They want to be in Wisconsin so are looking for the opportunity to grow in this area. We would be one of the first to receive an Idle Site Grant. Jim Rosenberg is from the Idle Site Fund, he brings up that the application has not been completed but he is sure it will make it.
