**P. Town of Neva Websire/Koss:** Tony says that we are the only website in Langlade County to have a website and that it is an unnecessary expense, we must post in either 3 public places or 1 public place and a website and could use the Counties. The WTA has advised that the town must own the website that we are posting on for it to be a legal posting. Discussion held. Tony makes the motion that we discontinue the website at the end of January when the contract ends, Herb seconds. Doug says that he will pay for the next year. Tony withdraws his motion and makes a new motion stating that if the town chair foots the bill he approves it, Doug seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.

**Q. Appointing Town Mower/Outside Maintenance:** Doug and Tom say that they have talked to Tim Cartier, and he wants the job. Discussion held. Tony asks to put maintenance salary on next month's meeting agenda.

- R. Highway Department Payment-Prepay \$85,000:** Doug says that the town of Neva has prepaid and should continue, Tony makes the motion to approve the \$85,000, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- S. Ceiling Tiles/Replace:** Doug says that we have been talking about replacing the ceiling tiles. Tony says we should address it next spring.
- T. Junk Yard/Cty. B:** Doug reads a letter he sent to W10081 County Rd B and W10080 County Rd B for being in noncompliance with Langlade County Code of Ordinance Section 11.05. Discussion held. Discussion held. Tony makes a motion to follow through on both complaints, Doug seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- U. Sowinski Farms:** Josh states that the town should be responsible for the cost of the culverts, there was never an estimate given to them before the culverts were installed. They are willing to pay the \$4,400 for the culvert but not the \$12,000 that we billed them for, discussion held. Tony makes a motion to approve accepting the \$4,400, Herb seconds. Doug Curler-abstained, Herb Ullman-aye, Tony Koss-aye, motion carried.
- V. RFC Report:** Tom says last night at the meeting the biggest thing coming up is getting a new tanker truck, the current one is a '99 international and needs to be replaced. They went to look at a few trucks, but nothing will be decided for at least 2 years due to how long it takes to price and build the trucks. Discussion held.
