- G. **ACT71-Clerk or Treasurer-info only:** Doug says it talks about the clerk and treasurer; towns may change from elected to appointed clerks and/or treasurers at a town meeting of the electors instead of voting on a referendum.
- H. **Rezone 014.0244.001:** There is a request to rezone a 1-acre lot to residential, discussion held. Tony makes a motion to approve the rezoning, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- I. **LRIP-info only:** Doug says that they are proceeding with the LRIP application for the road that is divided between 4 townships. Discussion held.
- J. **Junk Yard/Cty. B:** Doug says that it was kept on the agenda to say that they will have until the spring clean-up to clean the yard, before they decide further action.
- K. **RFC Report:** Tom says they met last night and went to multiple different places to view truck chassis and tankers, discussion held. Herb asks if they have applied to any grants, Tom says the budget hearing is in February, and they may be discussing some grants at that time.
- L. **Transfer Liquor License:** Steve McCabe is here asking to have a license transferred from Neva to Elcho. There are no available liquor licenses in Elcho, so he is looking for one from one of the other townships within the county. There is a \$10,000 fee to transfer the license between towns, discussion held. There are 6 active and at least two reserved within the township. Tony makes a motion to move forward with transferring one of the licenses to Elcho, contingent on talking to legal counsel, Doug seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- M. **Maintenance Salary/Duties:** Tom says that Tim is willing to take the maintenance job since Otto is retiring. Tony makes a motion to hire Tim Cartier as the maintenance man, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried. Tony will oversee Friday and Herb will take Saturday of the Spring Clean-Up. Tony said he will do the spring maintenance on the mower and cut the grass the first time. They will both donate 10 hours a month to doing upkeep in the town. Discussion held. Tony asks that the next time we have storm damage since the fire dept cleared the roads for the other townships that we should ask them to do the roads in Neva.

  - a. **Website:** Tony said he called the towns association due to Doug donating money for the township website, discussion held.
  - b. **Pay bills:** Tony makes a motion to approve the bills, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
