- G. Junk Yard/Cty. B-Info only:** Doug is working with Chris Arrowood on the junk yard issue.
- H. Variance 014-0582.003:** The variance is He is asking for a 25' set back instead of the usual 75' set back to stay within the regulations for the county. Discussion held. Herb makes a motion to approve the variance, Tony seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- I. Variance 014-0080.003:** They are asking for a variance of 36'. Tony makes a motion to approve the variance, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- J. Town of Neva Road Inspection:** Doug, Tony, and Herb went out on the road inspection and there was mainly crack sealing that needed to be done. Neva Lake Road will be pulverized and paved from the intersection with Moersch to the boat landing. There is a failed culvert, and the county is looking at prices to repair it. The county will pay for half, Neva will pay for ¼, and Price will pay for ¼. Town of Antigo and Polar are saying no to fixing their parts of Price-Neva Rd. Discussion held.
- K. Town Grass/Maintenance Status:** Doug has a letter from Butch for mowing the ditches for \$1790.00. Discussion held. Tony makes a motion to approve Butch mowing the ditches, Herb seconds.
