G. Junk Yard/Cty. B-Info Only: The county will contact the owners, and it will progress from there.

- H. Town of Neva Brushing/Trimming (Tony & Herb):** Doug asks if they have a report compiled or if they want to initial his report. Doug states that due to state statutes the roads must be kept safe for use by the people of the township. Wally asks about little Chicago and Hwy C and states that you must almost pull into the road to see oncoming traffic at the stop sign. Discussion held. Tony makes a motion to approve and initial Doug's plan with exceptions which he states don't need to be brushed. Doug disagrees and says it needs to be trimmed to make the roads safe, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried. Doug will send an email about the sections they disagree with.
- I. Roads; Price-Neva – Jurisdictional Transfer:** Doug states that he is talking to the chair from Price and he agrees to the transfer to Neva of a continuous section of road on the Price-Neva Road from O south would be ours. Discussion held. Town of Neva is combining .53 miles then .49 after a section of prices. 1.02 miles of road directly off O so that it is continuous. Tony says that at the Price Town meeting they will be reapplying for the LRIP program in 2028. He also states that in 2028 if they get the LRIP we will do the whole road in conjunction with Price. Herb says that if we go through with the jurisdiction transfer it will keep Price from potentially getting any LRIP funds. He states that there was an error at the state level when this was being addressed the first time. Discussion held. Tony says that nothing can be done tonight and they will wait to let Price reapply and do the other couple roads that could be done within the township.
- J. Resolution #333 Hazards Mitigation Plan:** Doug reads the update to Resolution #333 from Langlade County. Doug makes a motion to approve adopting the updated resolution, Tony seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- K. Variance 014-06187:** The variance is for Tod Peck on Neva Lake Road for adding a garage and it will be within the right of way. Discussion held. Tony makes a motion to approve the variance as stated, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
- L. Comprehensive Committee:** Herb says that when he went through the town of Antigo and that they did not have this step in the process of approving new zoning requests. Mike asks how it costs less money in Antigo than Neva, that there are no fees from the township, the fees are from the county. Mike states that 2 out of 10 people came to the town board meetings as they had already had everything explained to them and did not have to come to the meeting and had more support through the process, he states that if there is not support from the town board that they might as well dissolve the committee. Herb says that he just went to the town board and didn't have any steps before it either. Discussion held. Mike says that if the town board wants to take over, he will step back but asks if we are prepared to help people with their zoning issues.
- M. N6187 Cty. B – Info Only:** Doug states that the place on B had squatter issues after the owner passed away and now the new owners want to keep the property and clean it up. Doug told them about the spring cleanup and if they want to clean it then. Discussion held.
- N. RFC:** Tom says that the last meeting on Monday night and that there is nothing new except the truck has been delivered to Quinlan's and will be taken to Marion to get the tank done over the next year and a half and they were wondering if the insurance covers the truck in case of accidents and in October, they will have the budget meeting.
- O. Pay Bills:** Tony makes a motion to approve the bills, Herb seconds. Doug Curler-aye, Herb Ullman-aye, Tony Koss-aye, motion carried.
